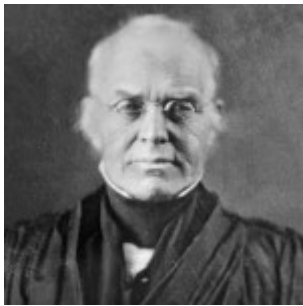

"It is indispensable, too, that the president should be a natural born citizen of the United States; or a citizen at the adoption of the constitution, and for fourteen years before his election. This permission of a naturalized citizen to become president is an exception from the great fundamental policy of all governments, to exclude foreign influence from their executive councils and duties.

It was doubtless introduced (for it has now become by lapse of time merely nominal, and will soon become wholly extinct) out of respect to those distinguished revolutionary patriots, who were born in a foreign land, and yet had entitled themselves to high honours in their adopted country. A positive exclusion of them from the office would have been unjust to their merits, and painful to their sensibilities.

But the general propriety of the exclusion of foreigners, in common cases, will scarcely be doubted by any sound statesman. It cuts off all chances for ambitious foreigners, who might otherwise be intriguing for the office; and interposes a barrier against those corrupt interference's of foreign governments in executive elections, which have inflicted the most serious evils upon the elective monarchies of Europe. Germany, Poland, and even the pontificate of Rome, are sad, but instructive examples of the enduring mischief's arising from this source."

# ***Will Justice Thomas be America's Constitutional Hero?***

By now most Americans know of Justice Scalia's mysterious death in Texas at lush spa resort while attending secret society convention. *But Thomas peppered Eisenstein with several questions about Second Amendment gun rights, a topic no other justice had asked about. He noted that the law allows someone convicted of a misdemeanor assault charge to get a lifetime ban on possessing a gun "which at least as of now results in suspension of a constitutional right."*

*"The suspension is not directly related to the use of a weapon?" Thomas asked.*

*Eisenstein said he was correct, but that Congress passed the law to prevent people accused of domestic violence from later using weapons against a family member. She noted that*

violating other laws can in some cases limit a person's free speech rights. Thomas then asked how long the suspension of the right to own a firearm lasts.

Eisenstein said it was indefinite.

## **History of Voisine and Armstrong and**

The Supreme Court agreed to hear the lawsuit filed by Stephen Voisine and William Armstrong III involved in domestic violence misdemeanor charges. An October 2015 article [stated the upcoming case](#) and Judge Scalia was suspected to rule on the case. The conviction on domestic violence misdemeanor charges resulting in barring of Voisine and Armstrong's gun ownership. The ruling was based on "The Lautenberg Amendment" which some feel violates both state commerce clause and even brings into the realm of possibilities of "Minority Report" preventive crime analysis based on speculation.

The general misconception is that any statute passed by legislators bearing the appearance of law constitutes the law of the land. The U.S. Constitution is the supreme law of the land, and any statute, to be valid, must be in agreement. It is impossible for both the Constitution and a law violating it to be valid; one must prevail. This is succinctly stated as follows:

The General rule is that an unconstitutional statute, though having the form and name of law is in reality no law, but is wholly void, and ineffective for any purpose; since unconstitutionality dates from the time of its enactment and not merely from the date of the decision so branding it. An unconstitutional law, in legal contemplation, is as

inoperative as if it had never been passed. Such a statute leaves the question that it purports to settle just as it would be had the statute not been enacted.

Since an unconstitutional law is void, the general principles follow that it imposes no duties, confers no rights, creates no office, bestows no power or authority on anyone, affords no protection, and justifies no acts performed under it....

A void act cannot be legally consistent with a valid one. An unconstitutional law cannot operate to supersede any existing valid law. Indeed, insofar as a statute runs counter to the fundamental law of the land, it is superseded thereby.

No one is bound to obey an unconstitutional law and no courts are bound to enforce it

[The riots followed postwar social tensions](#) related to the demobilization of veterans of World War I, both black and white, and competition for jobs among ethnic whites and blacks. The riots were extensively documented in the press, which along with the federal government conflated black movements with bolshevism.

Activist and author James Weldon Johnson, employed since 1916 by the National Association for the Advancement of Colored People (NAACP) as a field secretary, coined the term “Red Summer.” In 1919, he organized peaceful protests against the racial violence of that summer.

The Red Scare and the communist party (1919–1923)[edit]

From its inception, the Communist Party USA came under attack from state and federal governments and later the Federal Bureau of Investigation. In 1919, after a series of unattributed bombings and attempted assassinations of government officials, and judges (later traced to militant adherents of the radical anarchist Luigi Galleani), the US Department of Justice headed by Attorney General A. Mitchell Palmer, acting under the Sedition Act of 1918, began arresting thousands of foreign-born party members, many of whom the government deported. The Communist Party was forced underground and took to the use of pseudonyms and secret meetings in an effort to evade the authorities.

The party apparatus was to a great extent underground. It re-emerged in the last days of 1921 as a legal political party called the Workers Party of America. As the red scare and deportations of the early 1920s ebbed, the party became bolder and more open. An element of the party, however, remained permanently underground and came to be known as the “CPUSA secret apparatus.”

# IMMIGRATION CONTROL KEY TO PREVENTING INSURRECTIONS





### **"Prescott Bush and the Nazis: Union Banking Corporation**

Prescott Bush, later U.S. Senator and George W. Bush's grandfather, was a director of Union Banking Corporation, which in October 1942 was seized by the Office of Alien Property acting "under the authority of the Trading with the Enemy Act, as amended, and by Executive Order 9095, as amended." This has been the basis of charges on the internet and elsewhere that Prescott Bush had been engaged in illegal, perhaps even treasonous, relations with the Nazis. These charges are based on a misunderstanding of a sequence of events. Prescott Bush's relationship with Union Banking was legally beyond reproach, though its duration into the late 1930s raises ethical questions.

The Wall Street firm Brown Brothers Harriman, of which Prescott Bush was a partner, was linked to the rise of the Nazi regime through Fritz Thyssen, a German industrialist known to be a supporter of Hitler before Hitler became chancellor of Germany in January 1933. United Banking Corporation was founded in 1924 to manage Thyssen's U. S. investments. Several Brown Brothers Harriman partners, including Prescott Bush, served as directors of Union Banking. In March 1933 Hitler became dictator of Germany; in July of that year, he appointed Fritz Thyssen economic "czar" of the industrial Rheinland-Westphalia region. Thyssen finally broke with Hitler in December 1939, after Hitler had begun World War II in Europe.

Although Hitler's promulgation of the Nuremberg Laws in 1935 and subsequent anti-Jewish measures taken by the German government did not cause Prescott Bush and his fellow Brown Brothers Harriman partners to disengage from Union Banking, the directors found themselves in an embarrassing position with the outbreak of a war in which the U. S. might become

involved. Union Banking had been established as a subsidiary of a Dutch bank controlled by Thyssen's family. When the Netherlands surrendered to the Germans in May 1940, the U. S. government froze all Dutch assets in the United States, including Union Banking's assets, to protect them from the Nazis.

Despite their best efforts to extricate themselves, Prescott and his associates carried on as directors of Union Banking, operating under the supervision of the Treasury Dept., and a front page story in the *New York Herald Tribune* on July 31, 1941 publicized their connection with Union Banking. In November 1941 the U. S. government reclassified Union Banking as a German-owned business. Following U.S. entry into the war after the attack on Pearl Harbor, President Franklin Roosevelt issued Executive Order 9095 which established the Office of Alien Property and empowered the Alien Property Custodian to confiscate businesses owned by enemy nationals, a category that included Union Banking."

### **Prescott S. Bush as Treasurer of Planned Parenthood First National Fundraising Drive-1947**

[Planned Parenthood fundraising letter of January 8, 1947, lists Prescott S. Bush as treasurer of Margaret Sanger's first national fundraising drive](#). At that time, contraception was against the law in Connecticut, and the state had a large Catholic constituency. In 1950, during Prescott's first race for the U.S. Senate, the syndicated columnist Drew Pearson accused Bush of being a member of Planned Parenthood. Chapter 3: USCIS Authority to Naturalize Revisions and transfer of power.

October 1, 1991, Congress [transferred the naturalization authority](#) to the Attorney General (now the Secretary of DHS).<sup>□</sup> USCIS is authorized to perform such acts as deemed necessary to properly implement the Secretary’s authority.<sup>□ [3]</sup> In certain cases, an applicant for naturalization may choose to have the Oath of Allegiance<sup>□ [4]</sup> administered by USCIS or by an eligible court with jurisdiction. Eligible courts may choose to have exclusive authority to administer the Oath of Allegiance. <sup>□</sup>

This [chapter describes](#) immigration administration after the Homeland Security Act (HSA).

The 1892 [Church of The Holy Trinity vs. U.S.; 143 U.S. 457, 458](#) Supreme Court Ruling mirrored **Federal Immigration and Nationality Act Section 8 USC 1324(a)(1)(A)(iv)(b)(iii) above.**

U.S.; 143 U.S. 457, 458 Trinity Church VS. U.S. resulted in two part decision since it effected both "churches" and "immigration". The ruling on immigration of foreign English pastors for hire was:

["It shall be unlawful for any person, company, partnership, or corporation, in any manner whatsoever to...in any way assist or encourage the importation...of any alien or...foreigners into the United States...under contract or agreement...to perform labor or service of any kind". Church of The Holy Trinity vs. U.S.; 143 U.S. 457, 458 \(1892\).](#)

Ronald Reagan's amnesty changed Geo-political face of California and electoral votes. In 1991 Clinton administration Title 8 Immigration laws were transferred the "rule of law" to "Attorney General" under Chapter 3 revision act.

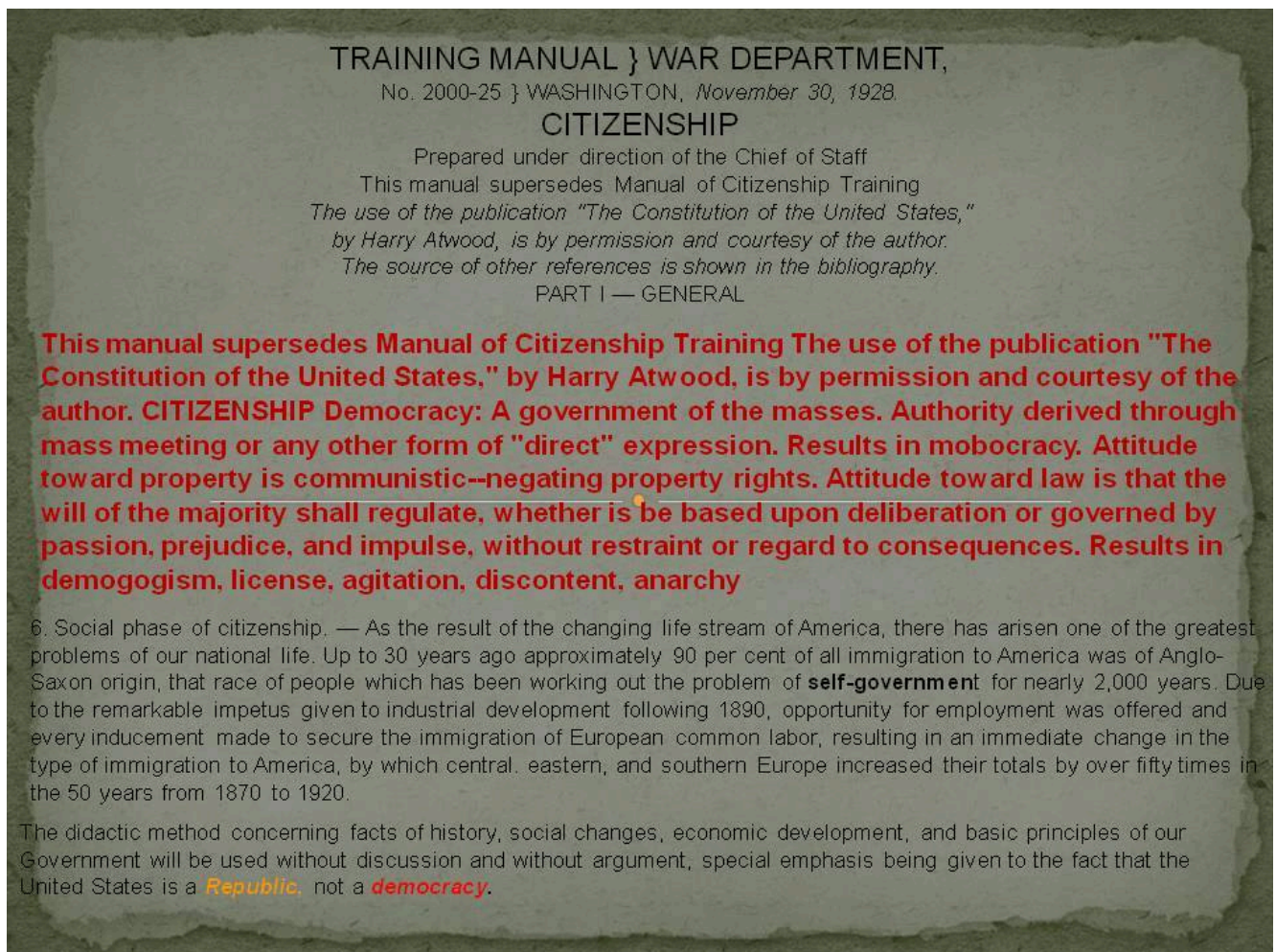

## ***Judicial Despotism***

[Jefferson on Government](#) “The Constitution... meant that its coordinate branches should be checks on each other. But the opinion which gives to the judges the right to decide what laws are constitutional and what not, not only for themselves in their own sphere of action but for the Legislature and

Executive also in their spheres, would make the Judiciary a despotic branch.” –Thomas Jefferson to Abigail Adams, 1804. ME 11:51

“To consider the judges as the ultimate arbiters of all constitutional questions [is] a very dangerous doctrine indeed, and one which would place us under the despotism of an oligarchy. Our judges are as honest as other men and not more so. They have with others the same passions for party, for power, and the privilege of their corps. Their maxim is *boni judicis est ampliare jurisdictionem* [good justice is broad jurisdiction], and their power the more dangerous as they are in office for life and not responsible, as the other functionaries are, to the elective control. The Constitution has erected no such single tribunal, knowing that to whatever hands confided, with the corruptions of time and party, its members would become despots. It has more wisely made all the departments co-equal and co-sovereign within themselves.” –Thomas Jefferson to William C. Jarvis, 1820. ME 15:277

“In denying the right [the Supreme Court usurps] of exclusively explaining the Constitution, I go further than [others] do, if I understand rightly [this] quotation from the *Federalist* of an opinion that ‘the judiciary is the last resort in relation to the other departments of the government, but not in relation to the rights of the parties to the compact under which the judiciary is derived.’ If this opinion be sound, then indeed is our Constitution a complete *felo de se* [act of suicide]. For intending to establish three departments, coordinate and independent, that they might check and balance one another, it has given, according to this opinion, to one of them alone the right to prescribe rules for the government of the others, and to that one, too, which is unelected by and independent of the nation. For experience has already shown that the impeachment it has provided is not even a scare-crow... The Constitution on this hypothesis is a mere thing of wax in the hands of the judiciary, which they may

twist and shape into any form they please.” –Thomas Jefferson to Spencer Roane, 1819. ME 15:212

“This member of the Government was at first considered as the most harmless and helpless of all its organs. But it has proved that the power of declaring what the law is, *ad libitum*, by sapping and mining slyly and without alarm the foundations of the Constitution, can do what open force would not dare to attempt.” –Thomas Jefferson to Edward Livingston, 1825. ME 16:114
